
Preconditions

SharePoint Services

Before the installation process, please make sure these services are running on the SharePoint Server:

- SharePoint Administration
- SharePoint Timer Service

Required Permissions


To perform the installation procedure, you must have the following permissions and rights:

- Member of the local server' Administrators group
- Member of the Farm Administrators group

Installation package

Download the zip file (*.zip) of the product from the <u>downloads page</u> and unpack it to the SharePoint Front-End server where the installation process will be performed.

Do not install Vitextra .wsp files directly with PowerShell or STSADM.

Installation


Open the folder where you have an installation package and run the Setup.exe file.



If you could not run the setup file, right-click the Setup.exe file and select *Run as administrator*.


Installation wizard will appear as shown below:



Click on **Next** to start the checking process to verify the server meets all the requirements for product installation.


After system check is finished, click **Next**.


Review and accept the End-User License Agreement and click Next.




Note

Web Application screen may be skipped if the product does not contain any Web Application scoped resources.


Wait while the product is installed.

Farm solution is a package that can be deployed to an on-premise SharePoint Farm. Farm solution has full access to system resources and other sites on the farm.

Microsoft Teams

Cloud version of SharePoint, a web-based collaborative platform within Microsoft 365 provides an extensive range of capabilities to store, share, and manage digital information, content, and knowledge of an organization.
