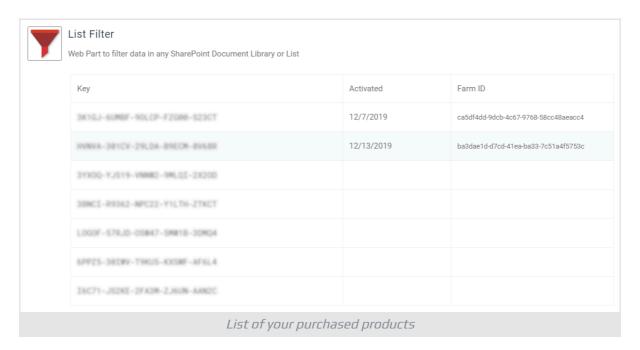

Copy any of the product keys that have not been activated yet.

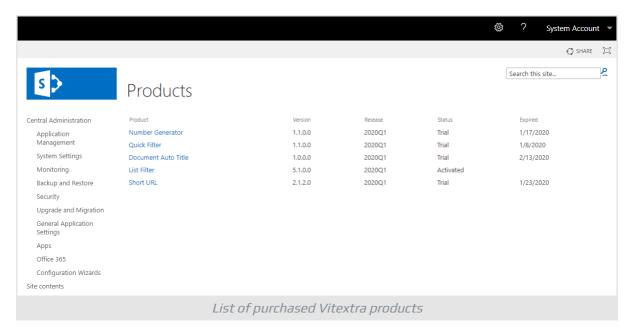
Activate Product

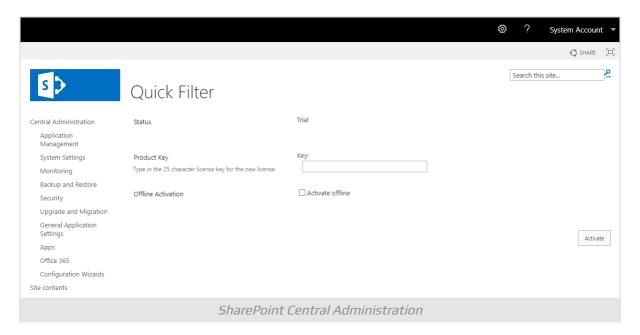


Select the product you want to activate in the list of installed products:
