To keep Vitextra apps up to date in your environment, you need to perform update operations.

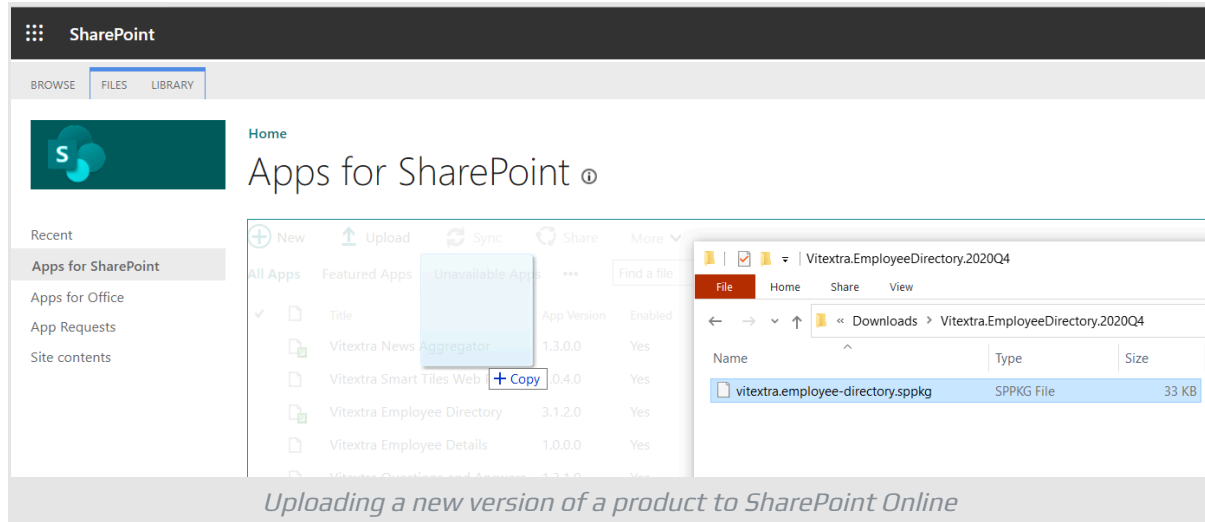

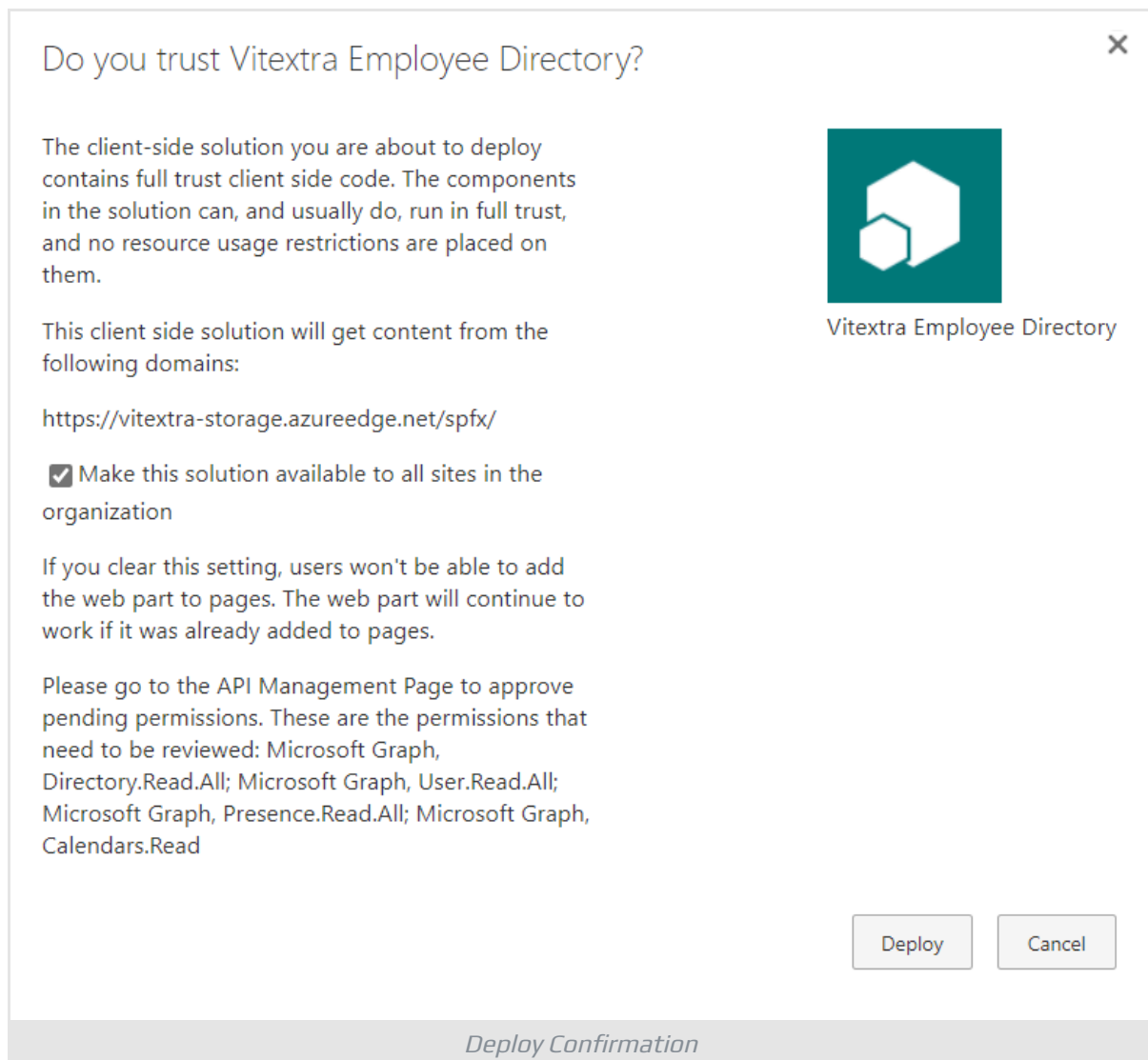
Extract zip-archive of the product to any folder on your PC.

Deploy

Open your SharePoint App Catalog, go to **Apps for SharePoint**, upload extracted .SPPKG file to the library and replace the existing one.



Once the new version of the package is uploaded, SharePoint shows up the confirmation dialog. Click the **Deploy** button to confirm the operation:

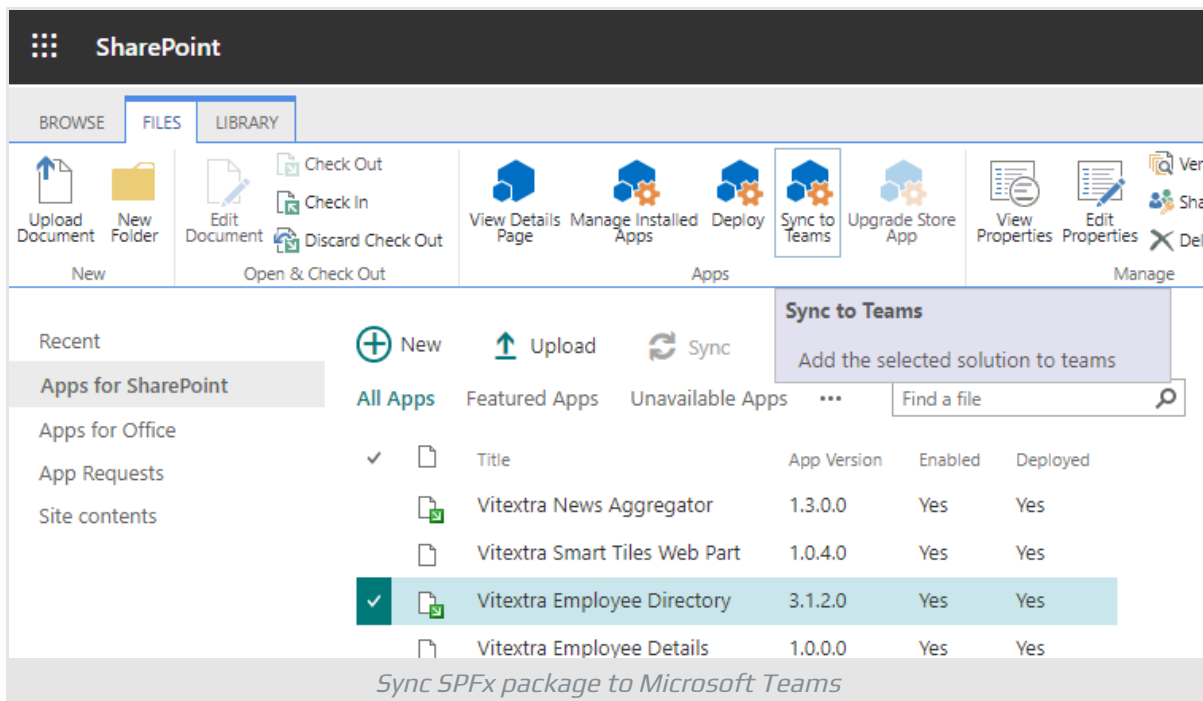


 **Note**
