

## Add Web Part

Open the page where you need to add the web part in edit mode.

Select the circled + icon. Scroll down and select **Smart Search** in the list of available web parts.



# Configuration

Open the configuration page of the Smart Search web part and set the following settings:

- 1 Mode Single Source
- 2 Source Meeting Recording
- 3 Default Search Query \*



4 Sort By - Last Modified 5 Sort Direction - Descending

Asterisk symbol for *Default Search Query* allows showing search results once the web part is loaded without needing the user to perform the search operation.



The last two settings (sort by and sort direction) are optional. Use them in case you need to show recently created videos on the top.




Publish the page to save changes.
