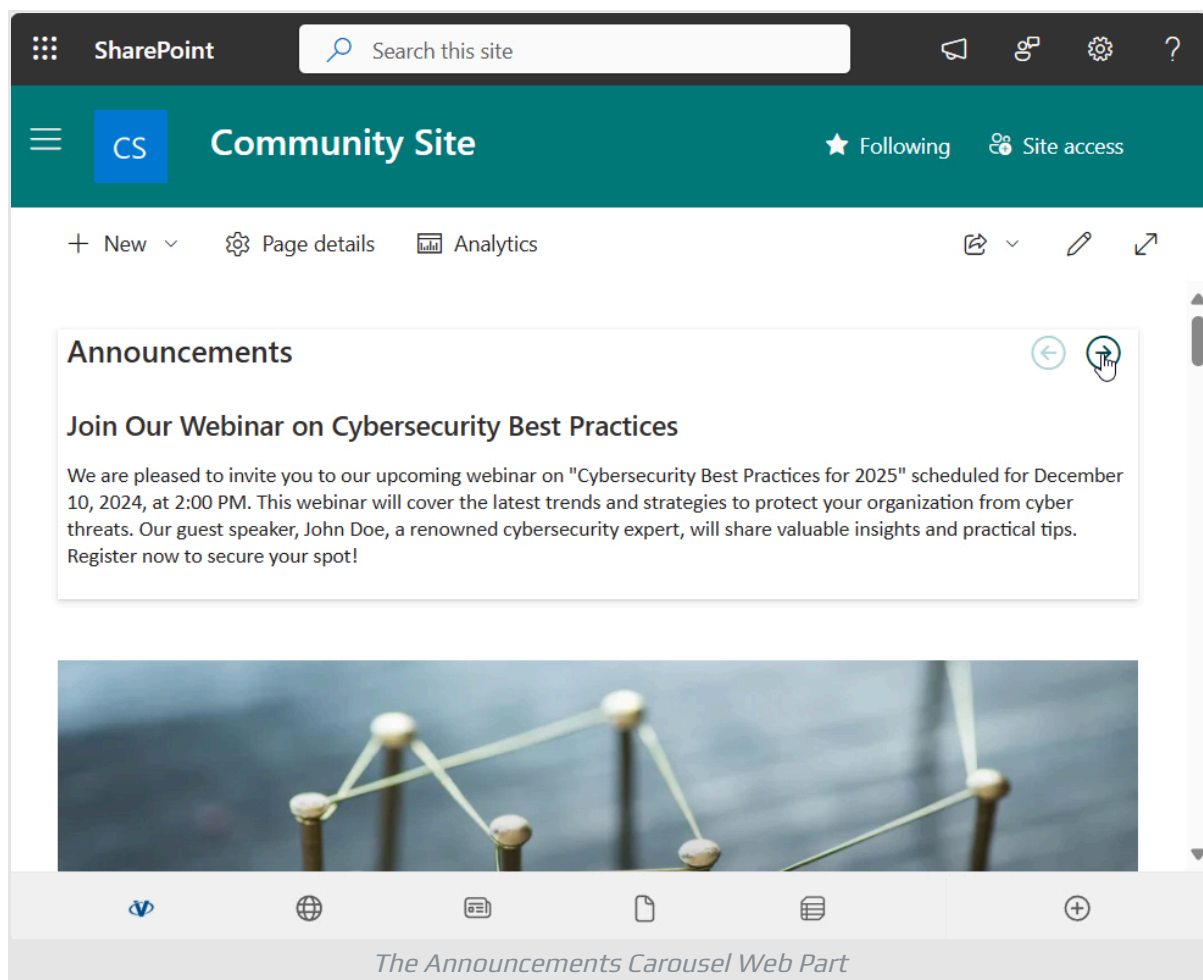

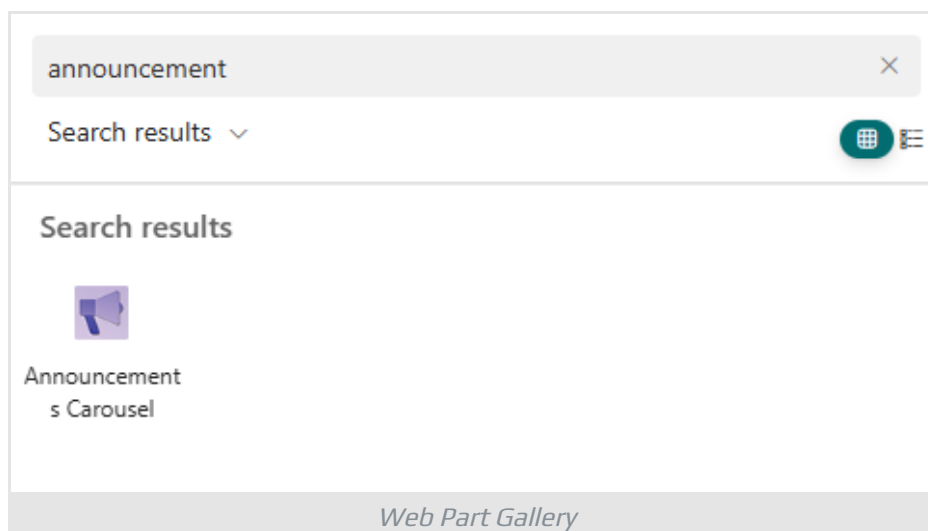
The Vitextra Announcements Carousel allows you to choose existing lists as data sources or create new ones with just a single click, making it incredibly easy to manage your announcements.

Adding the Announcements Carousel Web Part

How to Manage the Announcements

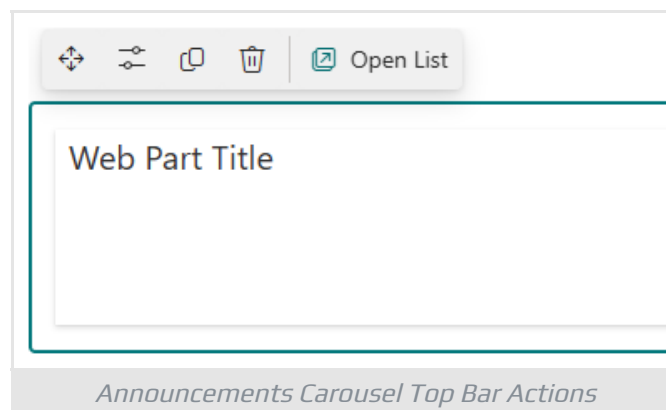
Managing announcements with the Vitextra Announcements Carousel web part is straightforward, as it leverages the standard Microsoft Lists app.

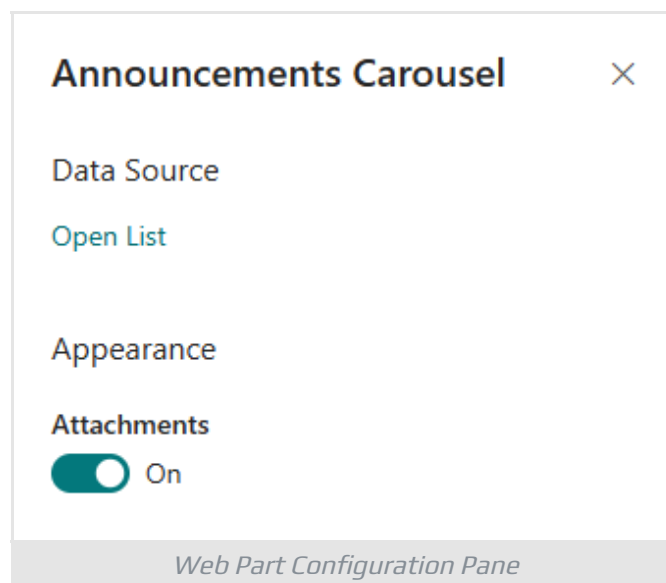
The Vitextra Announcements Carousel web part leverages the standard Microsoft Lists app to store data.

- 1 Click on the Open List Button in the Web Part Top Bar Actions: This option is available directly within the web part, providing quick access to the list.



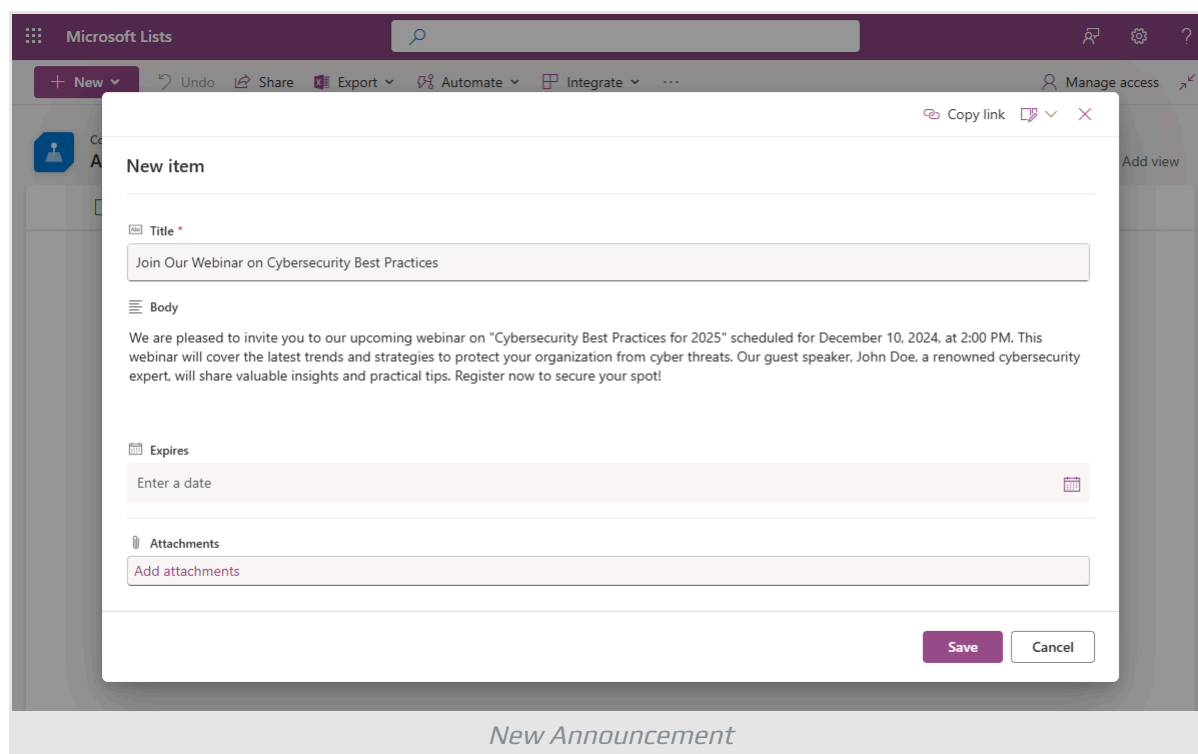
- 1 Click on the Open List in the Web Part Configuration Pane: When configuring the web part, you can open the list from the configuration pane.



1 Open Site Content and Find the List There: Navigate to the site content section of your SharePoint site and locate the announcements list among your site's content.

To add a new announcement, click on the "New" button within your selected list. Fill in the necessary details such as the title and body.



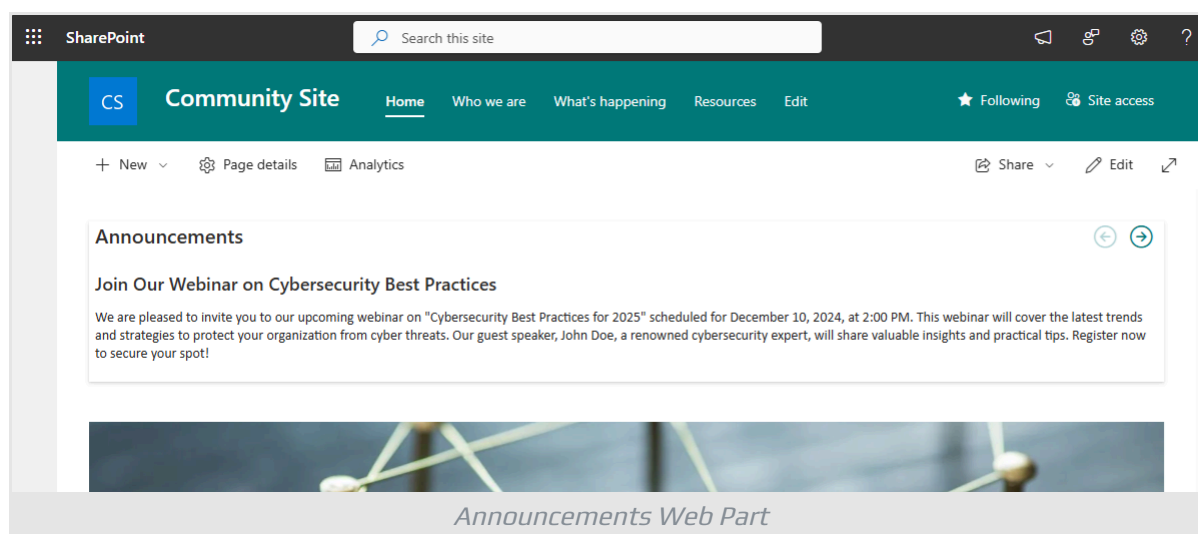
Editing Existing Announcement
